Blast from the Past: Part 1

JUNE 1993: Cabbagetown Reunion Day featured a day full of music from "Southern Cross", "Gopher Broke Boys", "Greasetrap", and the omnipresent "Slim Chance and The Convicts". Atlanta Dairy provided ice cream for everyone. We gave away a VCR (for those of you born after 1995, that's a video cassette recorder: A device for recording and viewing video), and a **Blockbuster** membership. Blockbuster was a place you could go to rent VCR tapes. Remember: Be kind. Rewind. Panorama Ray took a photo to commemorate the event. That photo now hangs at **Little's Food Store**.

JUNE 2002: Boulevard saw two major vehicle crashes. A tractor trailer overturned, knocked down a utility pole and spilled deisel fuel. And a car crashed into the home at the corner of Carroll Street and Boulevard.

JUNE 2004: Little's was celebrating it's 75th anniversary of doing business in Cabbagetown. Leon Little's first sale was a pack of *Lucky Strike* cigarettes for eleven cents. And in 2004, Jack Sobel welcomed his son, Jacob Wynn Sobel into the world.

JUNE 2005: Maria Locke was gearing up to open **Cabbag-etown GreenMarket**: An outdoor market where Cabbageheads could get fresh veggies. Nathan Bolster was heading up an effort to improve the Cabbagetown entrance to Krog Tunnel.

JUNE 2006: Tim Sullivan wrote a lovely profile on Lynne Splinter. Lynne detailed her dream of a greener Memorial Drive with a vibrant commercial scene. Lynne bemoaned the recent arrests of young couples in Cabbagetown Park who were arrested for doing what comes naturally. **Redfish** (currently **Grindhouse**) was the site of a **Chameleons UK** DVD release party.

Gerry Weber and the First Amendment

An independent central Georgia video journalist can argue his First Amendment case against the city of Fort Valley after officials tried to have his lawsuit tossed out, says a federal judge.

Judge Tilman Self in the Middle District of Georgia ruled this week that Kennon Dunn can continue with his claims that Fort Valley city officials violated his constitutional rights when officers arrested him for filming inside the City Hall lobby, which is a public space.

Attorneys for the city officials tried to have the case dismissed. Fort Valley, home to about 9,000 people, is about thirty minutes southwest of Macon.

In his decision, Self noted that the First Amendment protects the right to gather information about what public officials do on public property, including the right to record matters of public interest. "Pretty simple rule," Self wrote in his order.

Dunn, a military veteran who refers to himself on camera as Central Civilian Auditor, runs a YouTube channel called Central Civilian Auditors that has more than 8,000 followers. His videos show him testing his First Amendment rights in various public scenarios and, as a person with a disability, checking for accessibility in the public sphere.

"This decision vindicates citizen journalists' role as watchdogs and informing citizens about their government," said Dunn's attorney and Georgia First Amendment Foundation board member Gerald Weber in a statement Wednesday. "Our client was arrested for just filming in public places, and the judge says that arrest was clearly unconstitutional."

Some of Dunn's recent videos feature him walking into Marshallville City Hall and trying to make a verbal request for records and, separately, confronting a Macon state correctional officer who left his work keys in a locked prisoner transport van while shopping at Wal-Mart.

His lawsuit against Fort Valley officials centers on a 2018 run-in with police officers after he showed up at City Hall with cameras and began filming the lobby for a report he said he was doing on missing persons. He also filmed the mayor from a distance as she

worked on the other side of a glass door.

In an edited video of the encounter, Dunn is confronted by police officers while standing in the lobby. One officer asked Dunn about his "agenda" and told him he cannot take pictures inside the lobby, which is a public space. Officers became agitated when Dunn did not provide his name or ID.

Dunn, who walks with the assistance of a cane, was handcuffed and charged with disorderly conduct – a charge that was later dismissed. He is still banned from entering the Fort Valley Police Department or Town Hall without a police escort, even when trying to attend a public meeting.

City officials failed to show that Dunn "jeopardized the peace and safety or that anyone was reasonably alarmed (as opposed to merely annoyed) by his presence as is required by the loitering statute," the judge wrote in his order.


Dunn also claims the city has ignored requests filed under the state's open records act where he asked for documents related to his encounter with the Fort Valley police.

Nicole Lathouse Gilbert has been volunteering at AG Rhodes (a senior rehabilitation and living community at the corner of Boulevard and Woodward Avenue) for many years. When COVID-19 hit – for health reasons – the seniors at AG Rhodes were virtually cut-off from society.

Nicole understood that these are very lonely and worrisome times for our senior neighbors. So she sprang into action.

Nicole organised local children and neighbors to create beautiful, cheery artwork which was hung in the hallways of AG Rhodes. And that wasn't all. She created a *gofundme* page - raised \$755 - and used the money to provide tasty meals and treats from Sweet Cheats and Baker Dude.



Nicole said "Thank you to everyone that donated art and money to make this happen! The staff and the residents deserve to know that their community is thinking about them and wishing them well during this strange and difficult time. Thank you!"





"The ultimate tragedy is not the oppression and cruelty by the bad people, but the silence over that by the good people." Dr. Martin Luther King Jr.

When I was a kid, I learned to be a chameleon in various social situations so I could 'fly under the radar.' As a gay kid in the 1980s and early 1990s in suburban/exurban Atlanta, I considered it a survival skill.

How incredibly fortunate for me that being gay was something that might go

undetected, if only I played it cool. Our friends of African descent, Latin descent, Middle Eastern descent, etc. don't have that trick available to them. They can't put on an act and easily blend in with the white crowd.

Day after day, we see the impacts of unresolved racial inequality, oppression, and bigotry in this country. These senseless deaths smack us in the face and beg us to see the bitter truth of our built-in biases and prejudices relating to people who are different than us.

White guys like me have absolutely no clue what it's like to get pulled over by a police officer and wonder if one wrong move will mean the end of our lives. We don't have the faintest concept of what parents of a black teenage boy feel every time he leaves the house. We can't comprehend how going out for a jog in broad daylight could end up with us running into a killing field because someone didn't think we belonged there.

We don't know, and we can't know these things. What we can do is listen; listen with the intention of truly understanding. In the face of these tragedies that haunt us as if playing on an endless loop, I hear many leaders in affected communities ask for privileged people to go into these spaces to listen without offering up a 'solution' to ease our stinging discomfort. It's not easy to do. There's a time to act, of course. First, though, we must listen.

I recently watched a documentary about the Amadou Diallo murder in 1999. Amadou was an unarmed 23-year-old black man that was gunned down in the vestibule of his Bronx apartment by four white NYPD cops. 41 bullets were fired that night. The cops were all found not guilty of murder. Although I remember his name and the controversy around his murder, it shocked me that I didn't remember the fact that it occurred while I was living in NYC.

I want that to sink in, because it absolutely floored me. This tragic murder occurred in the same city I lived in as a 24-year-old, yet it didn't impact me enough to become seared into my memory. I went about my business for the next ten months living in NYC without any meaningful shift.

I'm ashamed to admit what I just wrote, and that's why it needs to be said. It's a glaring example of white privilege.

All of us in positions of relative privilege need to listen up and speak up when the opportunity to affect change presents itself. We are all human beings, and we deserve an equal chance to live.

To quote the poet Ella Wheeler Wilcox, "To sin by silence, when we should protest, makes cowards out of men."

A New Gateway to Heaven

This summer, Historic Oakland Foundation will construct a new pedestrian gate near the corner of Boulevard and Memorial Drive. After more than a hundred years, visitors will once again be able to enter from the eastern side of the cemetery. Once finished, the new East Gate will offer easier access to the cemetery for residents of Cabbagetown, Reynoldstown, and Grant Park, as well as for those coming from the BeltLine.

The original east gate was installed along Boulevard in 1899 and, after much debate, closed by Atlanta's Cemetery Commission in 1908. The new access point will be located near the site of the former gate, in keeping with historic precedent, and will allow a high volume of visitors to access the Cemetery without having to walk to the pedestrian gate further to the west on Memorial Drive.

The gate will make visiting the East Hill, Jewish Hill, the African American Burial Grounds, and Potter's Field more convenient. This project also includes the introduction of wayfinding signage to help orient visitors coming through the gate, interpretive panels, benches, and pet stations to add to the visitor experience. The anticipated completion date for the gate is summer 2020.

Historic Oakland Foundation Co-Executive Director Dr. Richard Harker said, "Knowing the incredible value that parks and green space provide to individuals and communities, we are thrilled to be able to expand access to historic Oakland Cemetery and provide visitors from the east a new way to enter and exit the park."
