
The variety of recipes is really amazing. Ingredients run from the standard to the exotic. There are recipes from some "old timers" – lifelong

Legislation has gone forward with accepting a donation from CI for sidewalk repair in conjunction with the city.

The city has selected a new location for the MLK Natatorium on Hilliard closer to MARTA. Will include an indoor pool and splash pad. Atlanta Housing Authority donated the land, Renew Atlanta provided funds.

Resident inquires about Krog Street demonstration project plan. Sidewalks were first priority which will address most urgent repairs. Next, they will address Krog Street improvements. Kwanza Hall is supportive. Resident inquired about painting yellow street lines on Krog. Natalyn will work on that. There will be a meeting on 9/9 on public works around street lighting.

Meditation Center and Revolution Donuts will be opening at Edgewood and Waddell. North

Ave and Highlands, a developer is trying to develop it with townhomes (near *Buddy's* and *Java Vino*), neighborhood pushing against it pretty hard. Parking lot south of *Manuel's Tavern*, they want to build a large mixed use building, neighborhood supportive. Will add a mini-parking deck behind Manuel's. Barton Hodges approved by NPU as Representative to Eastside Tax Allocation District. NPU Bylaws were emailed out twice to *Yahoo* and *Nextdoor* listservs, only included two changes. NPU Bylaws changes will be discussed at next CNIA meeting.

GEM (Formerly Memorial Drive Visioning Committee)No updates

Historic Preservation/Land Use - Matt Wise

• 700 Memorial (John Gordy): Have made 3 visits to HP over the last few months, will go before UDC in October. Property is 1.1 acres at corner of Tye and Memorial. Will be mixed use development with street level as non-residential (will be office or studio space, no restaurants allowed) with residential above. Is in Sub Area 5. Along Tye street, will have trees and porches to make it feel more residential. GDOT will not approve trees for now along Memorial, have build in a large planter.

Parking will have 112 spaces, required to have 105 spaces. Will include 2 electric charging stations. Trash will be located along Memorial Drive. Will accommodate bike parking with 2 racks on Tye and some in covered parking.

There are two loading zones near trash. Two-story part of building was inspired by Carroll Street buildings. Some residents on Tye street requested a study of shadows, this was done, shouldn't been a problem after 9a.

Resident inquires about Beltline Overlay - Memorial Drive portion accommodates Beltline requirements in terms of lighting and building set back. Will reuse garage as part of entrance to property. Suggest bringing rear elevation drawings prior to submission to UDC. Matt Wise to check whether single family homes can be built in Sub Area 5 re: concern of residential view into parking garage. Contact Matt Wise with questions/thoughts on this property in the next month.

• 719 Mollie Street vacant lot (Adam Stillman): Planning 3 BR/3BD with gross sq footage is 1,900 (city's sq footage 1,438). Being presented to UDC tomorrow. Plans for a shotgun house, asks for 5 or 6 variances which are unavoidable based on historically contributing structures.

723 Mollie is the only contributing house on the block face. Resident concern: there is no back deck, will block light to nextdoor neighbors, home is much larger than other Mollie Street homes, and public facade that faces park must be considered because home will be visible to park in the winter when trees shed leaves.

Resident concern that unfinished basement will eventually be finished and there will be more occupants, resulting in greater parking needs. Lot has probably been purchased by a developer. *Continued on page 8*



Where ya been? Where ya going? Off to Sea Again.

"This is not a boat with a helicopter pad and a hot tub," says Greg Sifford. But it's home for Greg and Duwan for half the year. It's a 36 foot Catalina sloop, built in 1983 called *The Blue Wing*. They are getting ready to leave Cabbagetown and head down to Florida where they'll put the boat in the water, start on a long list of repairs, buy a bunch of provisions and strike out for points south.

The design feature that really sold them on the *Blue Wing* was an aft cabin. They don't use it for sleeping. Rather, it's their "garage" they store provisions and spare parts. Duwan says spare parts are the most important things you can have when you're living at sea and depending on your boat.

Duwan first got the idea to live on a boat in 2000. She got the opportunity to go down to Florida and sail with a guy who just invited people to do it. She was hooked. A couple of years later, she met Greg and they bought a house in Cabbagetown. But the dream didn't die. When she brought it up to Greg. He said, "Hey, sounds like fun".

The two took some sailing lessons and chartered a boat a couple of times in Florida. In 2010, they made the big leap. They found the *Blue Wing*, and bought it. They sold most of their "stuff", rented out the house on Tye Street, quit their jobs and, three months later, they sailed off to the Bahamas.

The couple says it's a great way to see some off-the-beaten-path places and to meet others in the live-aboard community. They've spent three winters sailing the lesser-known islands of the Bahamas (there are 700 islands in the Bahamas). One

island they stopped at, Buena Vista, has just one lone inhabitant - Edward. He welcomed them and they spent an afternoon enjoying each other's company.

Duwan says the little islands with their tiny villages remind her of Cabbagetown: everybody knows everybody. People are friendly and will go out of their way to help one another.

Each year since then they come back to Cabbagetown during hurricane season (roughly May through September).

The couple has become the "go to" house sitters and pet sitters for C-town folks going on vacation. Greg is a handyman extraordinaire. They recently sold their house to the original renters (Paul and Vicki Freeman).

This year, Duwan organized a big project to get Bertha Wise's house painted. It was a huge success and got dozens of neighbors working together to get the job done.

Greg and Duwan have more expansive plans for this year's adventure. They're headed further south – Mexico (the Yucatan peninsula), Belize, Honduras, Guatemala and who knows – maybe Panama. "We always start out with a plan," says Greg. "But that usually goes out the window in a couple of weeks," adds Duwan. They both agree that the great fun of their lifestyle is just adapting to situations. Sometimes the weather dictates their plan. Sometimes it's the boat- you can't ever predict a malfunction. Sometimes it's just a whim.

One or the other of them says: "Hey, let's go check out that island." And they hoist the main and off they go. They've had some scary situations while at sea, but have always worked through them. Even though Duwan is quite prone to sea sickness, she says she wouldn't give up the amazing experiences they have had and will continue to have.

Agreater good Masquerade



Is mankind essentially good or bad? I choose to believe the balance tips in favour of good. I also believe we all must constantly strive to do better.

America is a relatively young nation. I often view us as teenagers in the family of nations. Lots of energy and ambitious but sometimes those raw, juvenile qualities get us into trouble. We do a lot of good... but we have committed more than our fair share of mistakes.

But we still have a long, long way to go, as illustrated by the recent history of Ferguson. We must do all we can to not only fulfill the vision that *black lives matter*, but move beyond that, to a point in evolution when we wonder how we could have allowed any of our brothers and sisters to feel the need to make that proclamation in the first place.

Black lives are not the only lives we have devalued in our national history. Native Americans, Women, Asians, Jews, Mexicans, Muslims, and more, have all bore an unjust weight upon their shoulders.

We must all strive towards greeting each other with an open hand (not a fist), and a smile (not a frown). We must all recognise the greater good in all of us. We must listen. We must seek to understand our neighbor and bring them in, not wall them out.

Neighbors, we wanted to keep you updated with the latest news on the permitting status of the Krog Masquerade.

Some background: the *Krog Masquerade* is a party that is scheduled to take place the evening of October 17th in the Krog Street Tunnel. The event is organized by the *Georgia Foundation for Public Spaces* (GFFPS) and caused quite a bit of controversy amongst local residents and Atlanta street artists when it was first held last year.

Residents were annoyed with the GFFPS's dismissive attitudes towards the concerns of the neighborhood, and artists were furious the public art they produce in the tunnel for no compensation was being co-opted for private profit.

An important step in the event permitting process is for an applicant to appear before the affected Neighborhood Planning Unit to explain the plans for the event and to answer questions about it from the public and the NPU board.

GFFPS filed the permit application a few months ago and was initially scheduled to appear at July's NPU-N meeting, but they notified the City – a day in advance – that they would not appear due to "illness."

They were rescheduled for August's meeting but did not show again and offered no explanation that time. For September's meeting, which took place on the 24th, the applicant again did not appear, citing "illness" once more.

They instead sent a proxy who clearly had not been briefed about the *Krog Masquerade* apart from the absolute basics, such as the date and start and end times of the event. She was not able to answer any questions from the public or the board and kept referring people to e-mail the organizer for further information. She seemed bewildered that any questions were being posed about the event at all.

I made a motion to not support the permit application, based on the facts that the event applicant did not appear before the NPU, an uninformed proxy was sent instead, no salient information was presented, questions could not be answered, and the fact that the applicant has generally shown a very dismissive attitude towards the concerns of Cabbagetown and Reynoldstown residents and towards the permitting process ifself. The motion received unanimous support from the board in the vote.

Chris Jenko, NPU-N Chair, filed a letter to key City personnel on the 25th to emphasize the vote of non-support and demand a permit not be issued. As of press time, the City has not issued one. Stay tuned to *Nextdoor.com* for the latest word.

The rear view mirror

Confusion, roasted pigs, flood waters, and Jane Fonda's grandson. This was all a part of our Cabbagetown history in the the month of October in years gone by. Here's a look back.

1997

Pam Ahern rallied her Cabbagetown neighbors to create a family park at the corner of Tennelle, Powell, and Wylie. After a ton of hard work, we celebrated the unveiling of Esther Peachy Lefevre Park in 1997.

1998

Nick Boxer was writing about fears that Cabbagetown was being taken over by developers who wanted to turn Cabbagetown into the next Virginia-Highlands. 197 Estoria St sold for \$49,900 (Zillow estimates it's value today at \$219,136.

1999

Cabbagetown Grill (now Little's) renamed it's grilled tuna sandwich in honour of Jane Fonda's grandson, Malcolm. Malcolm stopped in often and that was his favourite sandwich. A man was stabbed on Carroll Street. He refused to give details to the police.

2000

Cabbagetown mourned the passing of long-time resident, John Carroll Jr., who lived on Berean. Mr. Carroll was married to Betty Hamrick, who was raised in Cabbagetown. Many members of the Carroll and Hamrick families worked at the mill. APD recovered two stolen vehicles in Cabbagetown: One on Pickett's Alley, and the other on Gaskill. Police also apprehended a "wanted man" who was spotted walking down Savannah Street.

2001

79 Chester Street was on the market at a selling price of \$79,950 (valued at \$221,904 today).

2002

Police responded to a "shots fired" call on Wylie. They arrested a juvenile who claimed he was shooting at two males who were attempting to steal his car.

2004

Cabbagetown was promising that we would not run out of Chili for Chomp and Stomp. Sadly, we did in fact run out of chili. And we have run out of chili every year since. CNIA had \$10,000 in the bank. *Milltown Tavern's* liquor license was approved. In related news, CNIA actually had a Alcohol Policy Committee back then. It was chaired by Pam Ahern.

2005

In 2005, Cabbageheads were confused about who CI and CNIA were, what they did and what those letters stood for. Ten years later, some folks are still confused. 196 Reinhardt sold for \$199,900 (valued today at \$199,265).

2006

Chomp and Stomp was gearing up for it's FIRST "Romp".

2007

Cabbagetown Market and Little's roasted a big ol' pig on Carroll Street. The pig took 24 hours to cook. A bunch of bands played some music under a tent and the whole thing turned into a \$350 fundraiser for the neighborhood. David Thayer was writing about the lunacy of local politicans trying to make it illegal for folks to wear pants with a beltline worn below the buttocks. Cabbagetown said goodbye to Mark Wood who died in a tragic ar accident. He was only 49 years old. Ed Lindahl was the director of the 2007 Chomp and Stomp.

2009

Caroline Smith snapped the now iconic photo of a couple canoeing through the Krog Tunnel after the flood of 2009. Joe and Christina Farr got married. Cabbagehead Ben Sklaver was killed while on patrol in Afghanistan. 170 Savannah St sold for \$79,900 (valued at \$213,122 today). Someone broke into Stein Steel and stole two metal lawn mowers and a non-metallic weed whacker. Heavy metal music might have influenced the criminal.





Cabbagetown Initiative (CI) CDC. Minutes of the Monthly Meeting. August 10th, 2015. 7p. Cabbagetown Community Center. Minutes submitted by Karin Kane, Secretary. Next meeting will be on October 12th, 2015 at the Community Center. The monthly meeting is open to all.

Present at Meeting: Ashley McCartney, Erich Nunn, Jessica Stewart, Whitney Cheesbro, Katherine Dirga, Tova Baruch, Tom Deardorff, Barb Harper, Karin Kane, Todd Kane, David Lewis, Alicia Forsee, Ed Lindahl, ChrisMcMain, John Dirga (Chair Chomp Music Committee), James "Slim Chance" Kelly, Jake Elsas and Nina Caltabiano.

The meeting of the CI Board of Cabbagetown Initiative CDC was called to order at 7:03p on August 10th, by Ashley McCartney.

I. Approval of Agenda

The agenda for the meeting was distributed and approved by a majority of those present.

II. Review of Previous Minutes

The minutes of the previous meeting were reviewed and unanimously approved.

III. Consideration of Open Issues

1. General: Ashley McCartney

There were no July minutes, Ashley will reconstruct. Todd asked what constituted a quorum? Unless agreed otherwise, a quorum is a majority of its members.

2. Special Guest Jake Elsas And Nina Caltabiano

Jake attended the meeting to introduce his idea to make the old tattoo space (on Carroll Street) a History Center for Cabbagetown. He wants to create a 501c-3. Hopes to get funding from grants. Jake wants to procure Cabbagetown memorabilia from locations throughout the city and bring them here. He would like to partner with CI in this effort. Motion was made for CI to partner with Jake in his efforts. It was seconded and the vote was unanimous.

3. Parks: Tova Baruch

We now have the building permit for EPL Park. Tova talked about having a "Build Day" to raise awareness for the new pavilion.

Katherine wondered if the pavilion would be done by Chomp and Stomp. Tova felt that it would as we are virtually ready to go. CI needs to approve Joe Farr as our contractor to build the pavilion. His bid was approx. §14,000. Tova has the bid. Motion was made to approve Joe Farr as the contractor to build the pavilion in EPL Park. Seconded by Barb. Motion passed unanimously.

4. Status Of Chomp and Stomp: Alicia Forsee

The permit has been filed and we are off and running. Alicia is working on the sanitation plan. We are live with applications. Artists, Individual Chili cooks and restaurants are beginning to sign up. Alicia got 3 bids for the tents this year. Turns out *Atlanta Tent* from last year gave us the best bid. There would also be a music headliner this year. Dan Thompson would get vintage items from the basement t-shrts, cd's etc. and get these items sold. Dan will

also continue to address cash control for the event. We thanked Alicia for stepping up again to be our Chair, also thanked her for doing a great job.

5. Chomp Music Committee: John Dirga Chairman

John Dirga and David Lewis were asked to attend the meeting to address concerns about process, transparency, and communication regarding the bidding of sound and stage services and booking bands for Chomp and Stomp. Katherine Dirga was asked to recuse herself due to a potential conflict of interest. She agreed to do so. David Lewis expressed frustration at what he has perceived as significant obstacles to his participation in the above activities. John and others at the meeting disputed the veracity of those claims. After much discussion, Tom Deardorff moved that John be removed form the music committee, Erich Nunn seconded the motion. After further discussion, Alicia Forsee stated she would resign as head of Chomp if the motion were to pass, and Ashley asserted that removing a Chomp committee chair was outside the scope of CI's power. Tom then withdrew the motion. John Dirga was asked by Karin Kane to provide the Board with three (3) clear and concise bids for sound and stage by the following Friday so a decision could be made.

6. Beer Sponsor Status: Ashley McCartney

We have a proposal from *Atlanta Beverage*. They would like to be our beer sponsor for Chomp for §12,000. Ashley has the proposal. Some people still would like to give *Sweetwater* a chance, even though their offer was much less. Still we have not reached a decision. We need to find out if *Atlanta Beverage* is furnishing the manpower to move the beer around. Ed Lindahl will get the answers for us. Katie has raised issues about font and words used. Ashley is shocked for how little they are asking for. We are tabling, waiting for Ed's answer.

7. Sponsors: Ashley McCartney

Karin Kane asked what is happening with other sponsors. We as a Board hired Rick with *Mix-It Marketing* to procure sponsors this year. The Board need to be informed who these prospects are.

8. Garden: Tom Deardorff

Garden is growing all is well.

9. Cookbook: Barb Harper

Cookbook is almost done. Will request money to fund the effort.

10. Governance: Erich Nunn

Chris McCain is here to be a prospective Board member. Chris will consider and get back to us.

IV. Consideration of New Business

1. Mold In Basement: Ashley McCartney

Remediation has been done. Most of things have been moved back into the basement. Other items will have to be repackaged. V. Agenda and Time of Next Meeting: The next meeting will be held at 7p on September 14th, 2015 at The Cabbagetown Community Center. The meeting was adjourned at 9:50p by Ashley McCartney. Minutes approved by The Board.

CNIA Bylaws

Article I – Name and Purpose

1.02 The purpose of this organization is to bring together neighbors to inform, strengthen and improve our historic neighborhood. The organization serves as Cabbagetown's voice to City of Atlanta administration

Article III -- Meetings

3.01 Regular membership meetings of the Association shall be held on the second Tuesday of each month at the Cabbagetown Neighborhood Community Center. Unless otherwise provided herein, notice stating the date, time, place and agenda of the regular membership meeting shall be published not less than seven calendar days before the date of each meeting. Publication of meeting notices on the Association's website, in the Cabbagetown Neighbor, fulfills the requirements of this Section and will be the ordinary means of such notice.

3.05 Except as these bylaws provide otherwise, special notice shall be given in the manner set out in Article III, Section 3.01 identifying in as much detail as is practicable any motion proposing:

- (a)approval of expenditure of funds beyond \$500 not expressly provided for within the annual budget of the Association,
- (b) approval of a requested change in zoning,
- (c) review and approval or denial of any proposal for a Certificate of Appropriateness as heard and reviewed by the Association's Historic Preservation/Land Use Committee
- (d) any motion proposing an amendment to these bylaws
- (e) liquor license applications
- (f) changes in business licenses

Article IV -- Membership

4.01 (b) Business representation: A business owner or owners, in possession of a current City of Atlanta business license with a Cabbagetown address, may specify a single designee, which may be the business owner, to represent the interests of and vote on behalf of said business. If a business owner and a designee both attend a meeting, they cannot both cast a vote. The business owner(s) must complete a membership form for the Designee, which, if approved, will confer membership status to the individual by the same process as an individual qualifying under 4.01(a)(1) or 4.01(a)(2). A business may have only one designee at a time and the designee is the only individual allowed to represent that business. A business owner may designate themselves.

(c) Neighborhood delineation: The Cabbagetown Neighborhood shall mean that area as defined by the City of Atlanta bounded on the south by the center line of Memorial Drive and on the north by Hulsey Yard, on the east by the center line of Pearl Street, and on the west by the center line of Boulevard.

4.07 New membership forms will only be made available at CNIA meetings. Proof of residence may be required. The neighborhood membership roster will be made available at each CNIA meeting.

Article V - Officers

5.01 The officers of the Association shall be a President, Vice-President, Secretary, and Treasurer. The officers shall perform their

duties to the best of their ability, and as prescribed in these bylaws. The term of office shall be one year and an officer may only serve in the same role for three consecutive terms.

5.02 Functions of the Officers

(d) The Treasurer shall keep all financial records, receive all monies, sign all disbursements, and recommend action concerning the Association's financial affairs to the membership. The Treasurer shall be responsible for monitoring budgetary limits on disbursements, and reporting receipts and disbursements by each committee at each regular meeting as part of the Treasurer's report. The Treasurer shall also be responsible for the annual filing of Form 990 or any currently required documents with the U.S. Internal Revenue Service and the Georgia Department of Revenue, and for renewing the Association's annual registration with the Secretary of State of Georgia. The Treasurer shall be authorized to transact any business with any financial institution in which the Association deposits funds in its control, to sign checks or other financial instruments on behalf of the Association, and to conduct such other financial business of the Association as directed by the Membership. The Treasurer may write checks for amounts greater than \$500 not expressly provided for within the annual budget only when the President acts as a second signatory.

5.03 Nominations for officers and committee chairpersons will be made at the regular membership meeting in February and at the Annual Meeting in March, with the election to be held at the March meeting. Officers and chairpersons must be members of the Association. No person is eligible to be elected as an Officer unless they have attended at least three previous Association meetings within the previous twelve months. The term of office shall be one year and shall run from the close of the Annual Meeting through the Annual Meeting of the following year, or until their successors have been elected. Any officer may serve three consecutive terms in the same position. After a period of one year or more, the individual may run for that position and shall again be limited to two consecutive terms. A three year consecutive term limit applies only to Officers, not Committee Chairs. Officers are subject to the term limits in place at the time of their election.

Article VI - Executive Committee

6.01 The Officers of the Association, along with the NPU-N Representative, the chairperson of the Historic Preservation/Land Use Committee shall constitute the Executive Committee. The Executive Committee may also include up to 3 members at-large.

6.03 Regular meetings of the Executive Committee shall be held at a time and location at a frequency no less than quarterly. Notice in Cabbagetown Neighbor and an announcement on the Association's website, stating the date, time, and place of regular Executive Committee meetings, shall be published no less than seven (7) days before the date of each meeting. Special meetings of the Executive Committee may be called by the President. Except in exigent circumstances, at least three (3) days notice of any such meeting shall be given to the Association's membership. Executive Committee meetings shall be open to all Association members for observation.

Article VII - Standing Committees & Ad Hoc Committees

7.02 Each Standing Committee shall be composed of a chairperson elected by the committee membership and at least two additional volunteer members of the Association, unless otherwise prescribed by the Association. Standing Committees and Ad Hoc Committees should create their own written requirements for voting membership and submit to CNIA for review. The chairperson of each Standing Committee is responsible for maintaining records of all business coming before the committee, all correspondence, all recommendations to the Association, and for the transfer of records to their successor. A copy of all correspondence and agreements shall be made available to the Secretary of the Association. Documents and updates to the Committee shall be sent to the Communications Committee for appropriate postings on the Association's website and made available to the community.

Article VIII - Contracts, Loans, Checks and Deposits.

8.03 All checks, drafts, notes, orders for payment, or other forms of indebtedness for the amount of \$500 not expressly provided for in the annual budget or more require a second signatory.

Article X – Parliamentary Authority

10.02 The CNIA President or presiding officer will break ties.

Article XI - Conflict of Interest

11.01 A conflict of interest is defined as any member or a related person having a beneficial financial interest in or related to an action effected or proposed to be effected by the Association and that interest is of such financial significance to the member or the related person that it would reasonably be expected to exert an influence on the member's judgment if the member were to vote on the transaction. A related person means the Member's spouse or partner (or a parent or sibling thereof), child, grandchild, sibling, parent (or spouse or partner thereof), and any entity (other than the Association) of which the Member is a director, general partner, agent, employee or employer.

Article XII - Removal from Office

12.01 Any member, chairperson, or officer may be suspended or removed from office or from the official membership roll for cause, by making a motion and receiving a two-thirds (2/3) majority vote of the Association membership in attendance at a regular membership meeting, provided that such cause must have been presented as a resolution to impeach at the regular membership meeting immediately prior to the meeting at which the vote occurs. During the suspension or removal process, the member, chairperson, or officer must give up any access to Association bank accounts for the suspension period.

Article XV – Seal - PROPOSE TO REMOVE


15.01 The Board shall provide a seal which shall be circular in form and shall have inscribed thereon the name of the Association, the state of organization, and the words "Corporate Seal".

Article XVII - Dissolution

Upon dissolution of this organization, all remaining assets shall be distributed to an organization qualifying as a non-profit organization upon majority vote of the membership of the CNIA.


